Responsibility: It is clearly understood that Great Tours of China acts only as agent for the passengers and books transportation, accommodations, specified meals, adventure activities and other related travel services and assumes no responsibility, howsoever caused, for personal injury, damage, loss, accident, expense, delay, acts of God or military action beyond their control. Travelers' bookings are accepted by Great Tours of China as agent for the independent operators and the services provided by these operators are offered subject to the terms and conditions contained in the tickets, exchange orders or vouchers issued by them and/or their suppliers. Though Great Tours of China has made every attempt to choose the best suppliers available it has no control over their operators procedures and can not be liable for any personal injury or property damage which may occur whether this is caused by wrongful, negligent or arbitrary acts, omissions on the part of a supplier, its employees and others not under the direct control of Great Tours of China. The passenger ticket issued by the airline carrier is the sole contract between the passenger and the carrier. Great Tours of China is not responsible for unexpected transportation delays and changes, nor liable for additional expenses or loss of time that may be incurred. Great Tours of China shall not be responsible for any inadvertent errors on their website, listed in their brochure or other descriptive material. On advancement of deposit the depositors agree to be bound by the terms and conditions here mentioned.

Liability: Great Tours of China cannot be held responsible if the host country's internal infrastructure causes adverse affects, nor if these affects cause the ground operator from delivering the usual standard of service. While Great Tours of China has made every attempt to retain the services of reliable trustworthy ground handlers, they cannot be held liable for any routine or extraordinary variations to any tour or other problems which may arise. China, especially rural China, is by its very nature an exotic destination where changes in the details and timing of an itinerary can vary depending upon conditions prevailing and facilities available.

Insurance: Trip cancellation and travel insurance are required. Certain policy protections are only available within 14 days of booking your tour. This insurance is at an additional cost and is the responsibility of the trip participant to secure from an independent provider. Great Tours of China strongly recommends that all clients purchase minimum travel protection insurance coverage. Clients residing outside the USA must purchase independent travel insurance and provide proof of coverage.

Basis of Rates: All prices are per person based on two sharing a room and fares are quoted in U.S. dollars. While we will do everything possible to maintain the listed prices, they are subject to change.

Single Travelers: A limited number of single rooms are available at extra coast on a first-

come, first-served basis, but available cannot be guaranteed. Rates maybe locations specific and will be quoted, if available, upon request. We will make every effort to match single travelers who request a roommate.
